Biographical History

Born on January 21, 1870 in Chepachet, Rhode Island, John T. Ryan graduated from Boston University's School of Law in 1896, after which he worked as a lawyer with the U.S. Pension Offices in Boston. He married Cora L. Ward on December 21, 1899 in Dorchester, Massachusetts, where they lived until they moved to Wellesley, Massachusetts on May 8, 1900; they had a son and daughter together.

Ryan gradually built up his own law business in Wellesley doing private conveyance, probate work, and having connections with the Fred O. Johnson Real Estate company. He helped to start Wellesley's local newspaper, *The Townsman*, in 1906 and acted as its editor until he resigned the following year in 1907 to begin employment with the town of Wellesley. However, he continued to edit the editorial column for several years. From April 9, 1907 until April 1916 Ryan was the Clerk of the Board of Selectmen. His duties included serving as bookkeeper for the Highway Department, agent for Public Welfare and Soldiers' Relief. Ryan served as Town Clerk from 1916 – 1952. He was reelected without contest every year after 1916. Ryan also took an active part in the organization of the Wellesley Cooperative Bank in 1911. In April 1952, Ryan established a new Wellesley town record for completing 45 years of continuous public service for the town. He died a short time later on June 6, 1952.

In his spare time Ryan was a photographer, gardener and singer. He was a popular tenor with several male quartets in Boston, and sang in the Village Church choir for 20 years. He was also

a charter and life member of Wellesley Masonic Lodge A.F. & A.M., a member of the Massachusetts Town Clerk's Association, National Institute of Municipal Clerks, Inc., and the Norfolk County Republican Club.

Scope and Content

This collection includes personal and professional papers of John T. Ryan, as well as photographic negatives. The collection consists of two document boxes and one oversized box.

The collection also contains newspaper clippings, and it appears that these might have been added to the collection from the Wellesley Historical Society's subject files at some point, as the presentation of the materials closely resembles other subject files, and they date later than the accession of the collection (April 1955). Also included with the collection are handwritten notes on scrap paper about Ryan, his jobs, family and his home office desk; these have been put into a folder in the front of Box 1, labeled "Archivist's Notes," as they do not appear to be an official part of the collection.

The collection described in this finding aid is part of a larger accession, which includes various objects and printed materials in various formats. Unfortunately, these various materials have been separated over time from the boxes described here, their location(s) within the Historical Society unknown. Materials will be added to the finding aid as they are found. The photographic negatives were originally housed in a wooden box labeled "John Ryan Negatives."
